

## **CLCC Boat Slip and Rack Space Registration Form - 2023**



All CLCC Members wanting to moor their watercraft at a CLCC dock must register their watercraft(s) with the CLCC. The CLCC will then assign a dock slip and/or rack space and provide current year boat stickers. All watercrafts must display current year boat stickers for their assigned dock slip/rack space.

Starting with the 2021 budget, dock maintenance will be a separate line item and all funds and expenses will be tracked as such. For years our docks have been getting minimal care due to budget constraints.
